

General Information Regarding the European Union REACHⁱ Regulations

Dynisco is a producer of electronic assemblies, some of which contain Lead (below 0,1% weight by weight) and/or encapsulated liquid Mercury. Under the REACH directives, a threshold of one (1) tonne per year release must be exceeded to require REACH registration. ⁱⁱ Evaluated under latest Substances of Very High Concerns (SVHC) ⁱⁱⁱ list updated on January 17 th , 2023, Dynisco does not exceed the one (1) tonne per year release requirement on any product. Therefore, the REACH directives do not apply.	Viatran a producer of electronic assemblies. Under the REACH directives, a threshold of one (1) ton per year release must be exceeded to require REACH regulation. ⁱⁱ This includes Substances of Very High Concerns (SVHC). ⁱⁱⁱ Under normal use and disposal Viatran does not release any chemicals. Therefore, the REACH directives do not apply.

Article 33 of the REACH regulation states:

- Any supplier of an article containing a substance meeting the criteria in Article 57 and identified in accordance with Article 59(1) in a concentration above 0,1 % weight by weight (w/w) shall provide the recipient of the article with sufficient information, available to the supplier, to allow safe use of the article including, as a minimum, the name of that substance.
- On request by a consumer any supplier of an article containing a substance meeting the criteria in Article 57 and identified in accordance with Article 59(1) in a concentration above 0,1 % weight by weight (w/w) shall provide the customer with sufficient information, available to the supplier, to allow safe use of the article including, as a minimum, the name of the substance.

The relevant information shall be provided, free of charge, within 45 days of receipt of the request.

We continually monitor status of the REACH regulation so that we are aware of any changes that may affect ourselves or our customers, and we require that our suppliers provide written notification to us for any materials or components sent to us that require notification under REACH requirements. If we are informed of any components that contain substances that require notification, we will comply with our duties under the REACH regulations and notify our customers as appropriate.
